Town Manager Report for the weeks of July 25th and August 1st, 2016

The land transfer for the BIC has been re-scheduled for Monday August 8th.

The parking lot closing took place on August 2nd. We will start looking for grant options to build a better municipal parking area.

The Newton Road property closed on August 2nd. We are currently preparing the RFP for the demolition.

The Bid opening for the overflow culvert was held on August 5th. Markowski Excavating was the lowest bidder at \$2,124,938.38.

The RFP for the stormwater master plan engineering was awarded to Watershed Consulting Associates, LLC.

Our Worker's Compensation mod rate has dropped from 1.89 to 1.52. We have been working with VLCT/PACIF in getting this number down as this affects our premium for workers comp insurance.

I have been working on a new Memorandum of Understanding with the Friends of the Town Hall. It looks like we have come up with a reasonable agreement the works for the Friends and the Town.

Work continues on the Cobb Hill Road culvert. They are currently removing ledge in anticipation for the midweek delivery of the footings.

Recreation Department:

- Youth works finished their six weeks of volunteer work. They accomplished much: Painted shelter and bathrooms and out buildings at Estabrook, cut truckloads of overgrown sumac that had grown up next to the entrance, stained the deck at Kennedy Park Thomas overlook, painted all 4 dugouts at baseball diamonds at Neshobe and assisted the Neshobe PTO with the installation of 3 new piece of playground equipment by mixing cement footings. We look forward to working with them next year and creating a teen rec-program around volunteering with them.
- Fall programming has been released. Pre-season soccer and football camps, k-6 Youth Soccer, 1st 8th grade football, cross country running, and Youth theatre auditions will be starting over the next 1 month.
- New Movie Money Bonanza fundraising booklets are for sale through the rec department. \$25 gets you 2 free movie passes, 4 BOGO free and some other concession deals. These booklets expire on October 31st of **2017**.
- Looking for volunteers to help with Brandon Rec Soccer and our planning for Spooksville.
- Fall field prep will include replacing the wood backstop at our Neshobe site with a chainlink backstop.

Economic Development:

Economic Development – Olivia's Croutons is planning on their move to Brandon. The DRB approved their conditional use permit. They are slated to close on the building October 8th.
