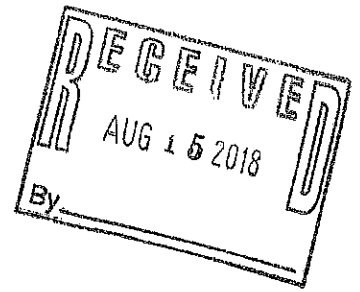

- 5) Provide sufficient number of employees for control purposes.
