3. Approve Request for Payment Plan

Dave Atherton reported the Doaners were present to request a payment plan, rather than a one-time upfront payment from the Sewer Commission as they are moving their business to the old bookstore location on Park Street that will require them to reapply for capacity for sewer. Bill Moore noted this is a good way for the Select Board to support economic development. Erynn Doaner advised the business is moving to where the Book & Leaf were located, and they will be putting in a new kitchen. They have signed a five-year lease with the hopes of extending it after that time. Their business has been in Town for five years and they have looked at a lot of different places to move their business and are happy that they don't have to leave the Town. Seth Hopkins suggested the Doaners work with the Town Manager on a payment plan. Andy Doaner proposed a 10% payment on March 1st and a payment every month of \$280.00, with the final payment in December. All agreed with the proposal. Ms. Doaner stated they are in the process of obtaining all required permits and plan to be open at this location on April 1st. Mae's Place will then be located at 10 Park Street and open seven days a week from 7AM to 2PM for breakfast and lunch, and will serve beer and wine.

Motion by Tracy Wyman/Doug Bailey to approve the request for a payment plan. The motion passed unanimously.
