RE: Liquor and Tobacco Licenses

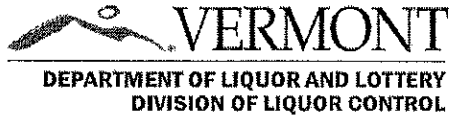
