The meeting was called to order at 7:00PM by Doug Bailey – Board Chair.

a) Approve Minutes of Board of Sewer Commissioners Meeting - October 9, 2023

Motion by Tim Guiles/Heather Nelson to approve the minutes of the October 9, 2023, meeting. The motion passed unanimously.

3. Public Comment and Participation

There was no discussion held.

4. Consider Purchase Order #12266 to Peak Motor and Pump for Hayward Gordon Pump - \$25,459.00

Steve Cijka stated this is one of the two pumps that pumps sludge from the holding tank to the aeration tank. There is usually one pump that runs 24/7 and both pumps were installed in 2005. This pump is broken and will cost \$20,000 to fix. A new pump will cost \$25,000 and it is suggested to purchase a new one rather than repair. Tim Guiles questioned the status of the wastewater system from the recent flooding event. Mr. Cijka reported that information had to be provided to the State indicating that everything could not be treated because of the overflow. Mr. Cijka noted this is typical of most plants and many pipes here were installed in 1930. There has been an infiltration study done and the Town needs to start fixing some of the things by either replacing or relining pipes in a cost-efficient manner. It is a multi-faceted and multifunction project as it includes the pipes and pumps being replaced. Mr. Guiles suggested the Board be forward-thinking and proactive to bring our wastewater system up to spec so that this is not a permanent issue. Heather Nelson thanked Mr. Cijka for his work in getting this information to the Board.

Motion by Tim Guiles/Heather Nelson to approve Purchase Order #12266 to Peak Motor and Pump for \$25,459.00. The motion passed unanimously.

5. Adjournment

Motion by Tim Guiles/Brian Coolidge to adjourn the Board of Sewer Commissioners meeting at 7:10PM. The motion passed unanimously.
