No interested party status was requested.

Larry Stevens and Seth Hopkins were sworn in.

Seth: Provided Exhibit A (packet from the State of Vermont on the Act 250). This would be Segment 4 of the Route 7 project. There is no water, no sewer and no utilities that will be disrupted by the project. This would start at the driveway south of Otter Valley to the Pittsford town line.

The proposed reconstruction project is to address safety concerns. The scope of the project includes the removal and disposal of the existing concrete road, the widening and full depth reconstruction of US Route 7, replacement of Bridge No. 110 (box culvert), extensions of Bridges 111 and 112 (box culverts), grading, drainage, relocation of aerial utilities, paving, approach work and incidental items.

The Town of Brandon has looked into criteria 6, 7 and 10 with no concerns. There will be no educational impacts other than a safer road near the High School. There is no town water, wastewater or other services provided to that section of the road and the Sate provides the maintenance to that section, with this no impact will be made to criteria 7. The purposed project and scope is in accordance with the Brandon Town Plan and the Rutland Regional Plan as required by criteria 10.

Bob: The impact would be the construction itself.

Seth: It will be an impact while traveling Route 7 during the construction period.

Jim: What does the timing and duration of the project look like?

Seth: It would be in 2026 for approximately a construction season, which would be April through November. There will be alternating one-way traffic during the project.
