
MINUTES OF JANUARY 26, 2026

SELECTBOARD

- 1 Chair Doug Bailey called the meeting to order at 7PM. All selectboard members were seated. Motion by Reniche-Smith/Haylon to adopt the posted agenda. Voted 5-0.
- 2 Bailey offered a reminder of the Pre-Town Meeting this coming Saturday at 11AM downstairs in the Town Hall. There will be a Zoom attendance option; use the regular selectboard Zoom sign-in details. This is a special selectboard meeting and the agenda is posted on the selectboard page and the bulletin boards. The purpose of the Pre-Town Meeting is to present the proposed FY27 budget before early voting starts.
- 3 Rep. Todd Nielsen spoke to the meeting on legislation he has been involved with in Montpelier. The two bills he focused on concerned emergency housing / homelessness and immunization recommendations. He took questions from the public present.
- 4 Motion by Reniche-Smith/Coolidge to consider items 4a through 4f as a consent agenda. Voted 5-0. Motion by Reniche-Smith/Haylon to approve the consent agenda. Voted 5-0.
- 5 Reports to the selectboard were provided by the town management team. Please see app-generated notes appearing below for topics discussed. No votes were required.
- 6 Motion by Coolidge/Reniche-Smith to approve the certificate of highway mileage. Voted 5-0.
- 7 Motion by Coolidge/Haylon to approve the certificate of no appeal of 2025 Grand List. Voted 5-0.
- 8 Motion by Haylon/Ethier to approve official warning for Town Meeting as presented. Voted 5-0.
- 9 After discussion, the board took no action on any selectboard position regarding the budget committee articles to be voted on the floor of Town Meeting. Reniche-Smith noted that 17 VSA §2646 (18) speaks to creation of an advisory budget committee and 24 VSA §1147 sets forth their duties.
- 10 Public comment on other items was called for; Hopkins stated the police fleet size was an open question.


The board recessed at 7:39. The board reconvened at 7:49.

- 8 Motion by Haylon/Reniche-Smith to enter executive session per 1 VSA §313(a)(3) regarding the appointment or employment or evaluation of a public officer or employee, to include the town manager. Voted 5-0. The board entered executive session at 7:49.

Motion by Reniche-Smith/Coolidge to exit executive session at 8:00. Voted 5-0. No action required.

- 9 Motion to adjourn by Coolidge/Haylon. Not debatable. Voted 5-0. 8:00PM.

Notes on Selectboard Meeting Created on January 26, 2026 at 7:00 PM by Minutes AI

1 - Agenda adopted as warned.

2 Opening Remarks

- The pre-town meeting will be on Saturday, January 31 at 11:00 a.m. in the same room. If the room is too crowded, the meeting will be moved upstairs.
- The pre-town meeting will use the same Zoom setup as the select board meeting.

3 Representative Todd Nielsen's Remarks

- Todd Nielsen states that traditional funding is uncertain, so it is important to focus on the issues that can be controlled.
- He discusses H594, an act related to establishing the Temporary Emergency Housing and Accountability Program and the Return Home Program in fiscal years 2027, 2028.
 - In fiscal year 2027, \$30 million will be spent. In 2028, \$25 million will be spent.
- He discusses H545, an act related to issuing immunization recommendations.
 - He voted no because he didn't like how they didn't have a schedule for children.
 - He states that he has constituents that feel strongly about the bill's integrity.
 - He believes in consumer protection to notify patients specifically of their assumptions of liability in this case.
 - "Our state should care enough about the patient to inform them and require their consent when they are assuming all liability for the outcome of receiving a state recommended immunization. And then they have no legal recourse if something goes wrong."
- Everything is live streamed on Vermont Gov under committees.

Questions for Todd Nielsen

- Billy Bullock asked why Rep Nielsen voted no for H545.
 - Nielsen responded that if the vaccine is bad from the manufacturer, there's no recourse.
 - He stated that he is unvaccinated for COVID.
- Bullock stated that Nielsen's vote was a shame and that the bill is important to the health and welfare of children, adults, and the homeless.

4 Consent Agenda Vote

- Motion to adopt a consent agenda for recurring matters, including:
 - Minutes of January 12
 - Warrant liquor license renewals
 - Tobacco and tobacco substitute license renewals
 - New liquor license for the Amateur Sports Bar
 - New tobacco and tobacco substitute licenses
- Motion seconded.
- All in favor, say aye. Opposed? None.

Questions on the Motion

- Question about the Amateur Sports Bar LLC: "I have never heard the name of the Amateur sports Bar llc. So tell me who that is."
 - Believed to be the bar opening in the former Ripton Mountain Distillery space by Andy Doaner.
- Ralph's questions:
 - BMI fee for Town Hall answered by Bill Moore: Yearly fee for music licensing.
 - Bill to The Reporter answered by Seth Hopkins: From the previous fiscal year, for an Energy Committee flyer in The Reporter. Being paid from Energy Committee funds but hitting this fiscal year.

Vote on ABCDEF

- All in favor, say aye. Opposed? No.

5a Town Manager's Report — Mr Hopkins

- No updates to the published report, except for the long duration snowstorm.
 - Town crew working hard, trying to work safe.
 - No phone calls about road conditions.

- No phone calls for emergency warming shelters over the weekend.
- Bill Moore streamlined telephone, Internet, and fax services with Comcast.
 - Estimated savings of \$500 a month.
- Shirley Markland resigned from the Historic Preservation Commission, creating a vacancy.
- Vacancies on boards and commissions:
 - Development Review Board (alternate)
 - Planning Commission (alternate)
 - Energy Committee (member)
 - Rutland County Solid Waste District (member representing Brandon)
 - Historic Preservation Commission (member)
- Budget summaries and tax estimators sent to the Herald, the Independent, and Lakeside News.
- Cecil Reniche-Smith highlighted that Historical Preservation Committee member qualifications are in the town policy/ordinance on the website.
 - Includes architecture, history, archaeology, and land preservation.
 - Members do not all have to be from Brandon if needed to find qualified individuals.

Comments for Mr Hopkins

- Kudos to the highway department for their long hours.

Questions from the Public for the Town Manager

- Brent Buehler: Running low on salt again.
 - Downside to stockpiling: Must keep it dry.
 - Salt shed is undersized.
 - Hoop building could be used for salt storage, but then nothing else due to corrosion.
- Congratulations on Comcast relationship initiated by Bill Moore.
 - Guaranteed state pricing.
 - Contract is at least two years, maybe five years.

Town Events and Announcements

- Vermont's Agency of Natural Resources will be in the meeting room on January 27th for public meetings regarding rulemaking amendments to Vermont's use of public waters rules.
- Laura Dlugolecki will lead a meeting on February 6th at 5:30.
- The Brandon Town Hall will host a trivia competition fundraiser for the Brandon Independence Celebration Committee on February 6th.
 - Food by Maes Mobile, adult beverages by Red Clover, soft drinks and popcorn available.
 - Quizmasters: Bill Moore and Molly Kennedy.
- One Room Theatrics, directed by Mike Mitrano, will use the town hall for practice and performance space from February 8th-14th.
 - Performances of "All I Really Did Need to Know I Learned in Kindergarten" on February 13th and 14th.
 - Tickets at oneroomtheatrics.com.
- Spring sports and summer camp ideas are being accepted.

Union Street Easements

- Working slowly through questions about Union Street easements.
- V Trans has offered assistance with the easement process.

6 Certificate of Highway Mileage

- There are no changes to the certificate of highway mileage.
- This determines the amount of payment the state makes to the town for state aid to town highways.
- The town has 71 miles of roads that receive some aid.
 - Class 1 (Route 7 and 73 inside the village): most aid.
 - Class 2 (16 miles, roads between Brandon and other towns): good amount of aid.
 - Class 3 (40 miles, roads inside Brandon): very little aid.
 - Class 4/legal trail: no aid.
- Motion to approve the mileage certificates was made, seconded, and approved.

7 Certificate of No Appeal or Suit Pending

- This certificate for the 2025 grand list, provided by the assessor, means nobody is suing the town and there are no appeals in process.
- Motion to approve was made, seconded, and approved.

8 Official Warning for Town Meeting

- Town meeting is scheduled for Monday, March 2nd at 7pm.
- The warning was prepared by the town clerk.
- All appropriations requested this year were requested last year, with no increased appropriations.
 - \$1,000 from the Chamber of Commerce is not being requested this year.
 - \$50,000 for capital funding, approved last year, is not being requested this year.
- Motion to approve the warning for town meeting was made, seconded, and approved.

9 Select Board Position on Budget Committee Articles

- There will be two floor votes at town meeting:
 - Whether to have a budget committee.
 - If so, whether members should be appointed or elected.
 - If elected, the election would be in August.
- The Select Board will not take a position on the budget committee articles.
 - "Personally I, I don't think the select board should take a position on it. It's kind of like putting a thumb on the scale. I'd like to let it be."
- There will be no opportunity to vote online, must be present at the meeting.
- Clarification was requested on the guidelines and protocol the budget committee should fall under.
- The board prepares a budget and presents it to the committee for review and comment.
- Statute states that if a municipality creates an advisory budget committee, the committee evaluates the municipality's budget and makes recommendations to the select board.
- In the past, the budget committee worked in conjunction with the board, attending budget meetings and voicing opinions.
- Public was invited to attend meetings, with participation from Barry, Brent, Jan Coolidge, Karen Rhodes, and Pat Welch via Zoom.
- Earlier in the year, it was believed that having members of the budget committee at each meeting fit into the ambiguous language of the statute.
- Concern that the statute casts the budget committee as a review board rather than a collaborative one.
- It is argued that the previous method of operation still fits the statutory language.
- The nature of the budget committee will be determined by whoever is elected or appointed to it.
- The current approach seeks common ground and consensus between the board and additional members.
- Jan Coolidge stated that the budget committee was initially separate, but after a few years, they recommended coordinating with the select board to avoid duplicating the process.

10 Public Comment and Participation

- Mr. Bueller asked if there was a consensus on the police car fleet.
 - The answer was to be determined.
- The police budget is under year-to-date figures by about \$255,000.
- Recognition of Liz Beth Alvarado, Brandon resident and former Rec director in Pittsford, for her work.
- A recess will be taken before going into executive session.

11 Executive Session

- Motion to go into executive session per 1 VSA 313 (a) (3).
 - Appointment or employment of an evaluation or evaluation of public officer employee to include the town manager.
